17 Any ABC Board violations and/or incidents that would lead to an ABC Board violation are
18 attached for the Assembly's evaluation.

20 There are no taxes owing.

21
22 Anchorage Municipal Code 21.03.040C.4.a states that any use that includes the retail sale
23 of alcoholic beverages, with the exception of a restaurant or eating place that sells beer
24 and wine for consumption only on the licensed premises, shall be considered by the
25 assembly. **There are special land use permits for all of the above establishments that**
26 **fall under AMC 21.03.040C.4.a.**

27
28 Anchorage Municipal Code 21.03.040C.4.b requires that a restaurant or eating place that
29 sells beer and wine for consumption only on the licensed premises, shall be considered
30 by the director of the Planning Department. **There are special land use permits for all**
31 **of the above establishments that fall under AMC 21.03.040C.4.b.**

32
33 Alaska Statute 04.11.480 provides that if the Assembly wishes to protest the issuance,
34 renewal, relocation or transfer of a liquor license, it may protest within 60 days following
35 receipt of the application and the protest will be honored unless the ABC Board finds the
36 protest to be arbitrary, capricious and unreasonable. **The last day to protest is March 5,**
37 **2017.** February 28, 2017 is the last scheduled regular Assembly meeting before the end of
38 the protest period.

40 **Approval of this memorandum is the Assembly's NON-OBJECTION to the**
41 **applications filed with AMCO for the ABC Board for the 2017/2018 liquor license**
42 **renewals for the above establishments.** The Municipal Clerk is authorized to notify the
43 AMCO of the Assembly's action and is authorized to sign on its behalf.
