4/6/2019 CER Advisory Board Meeting

- Proposed the CER Advisory Board pass a motion "authorizing and establishing" a Cemetery Steering Committee.
 - Was discussed that the CER Advisory Board does not have the authority to "authorize or establish" such a committee, they are only empowered to comment on land use issues in the CER area.
 - The Advisory Board did pass a resolution supporting the CER Cemetery effort, and encouraging/requesting that the Parks and Rec, HLB and other MOA entities cooperate and help identify potential sites, and that local community councils solicit members to makeup a steering committed.
 - Comments from the members on the Advisory Board were positive with specific comments:
 - Discuss with CER Foundation which may have some remaining funds to assist with this project.
 - Discuss with Chamber of Commerce about having a booth at Bear Paw to provide information to public

4/10/2019 Birchwood Community Council

4/10/2019 Eagle River Valley Community Council

 not have a quorum necessary to pass a resolution supporting the project. They also did not

 meeting (May).
