## A. 7:07 p.m. City Assembly

#### 1. John Weddleton

Explained Emergency Order powers. Plastic bag ban is being temporarily suspended. Talked about curbside service permits for food, alcohol, and marijuana establishments. Mask mandates are discussed.

Crime numbers are down. Talked about changes in codes with relation to B-3 and conditional use zoning.

# 2. Wendy Woolf, Willow Weimer

With reference to Cy Two Elk seeking to vacate an easement on his property in Bird Creek, Wendy and Willow explained history of easements and dates of validity for types of easements.

#### 3. Suzanne LaFrance

Explained that rent relief programs were only for rents, not mortgages.

Talked about Bond Measures that are on the ballot totaling \$60M. Areawide facility bonds are \$8M in two separate measures.

Tax levy for leasing capital assets via lease as opposed to loans not to exceed \$1.25M for body cameras and IT programs for APD.

Talked about Alcohol Tax Revenue and uses.

Title 17 and Leash Laws on standby.

Weddleton mentioned Assembly pay raise to \$60,000/ year.

Piper asks about Marijuana law changes and separation of uses with regards to churches, playgrounds, schools, and other businesses including Drug Rehabilitation centers.
