Wow, this summer is going by fast. I hope that all of you have taken the opportunity to enjoy some of what living in this paradise is all about.

Next month, ERCC will resume bi-monthly meetings. We will meet at 7pm, September 8, in the muni conference room above Garcias' Restaurant on Business Blvd.

There has been a flurry of new construction this summer in Eagle River. Two new subdivisions are being developed off of Monte Road, one an 8 lot project and the other a 13 lot project. Construction has begun on the 37 lot single residence development off of Old Eagle River Road. Upon completion, those projects will put a lot of traffic pressure at the intersections of Old Eagle River Road & Monte Road and Old Glen & Monte Road. Credit Union One is building a new branch at the intersection of Business Blvd. and Regency Drive. Parking and access to Baldy is still an issue and as of yet unsettled. Permitting for a new subdivision up there has been approved as has permitting for another development phase of Powder Ridge. Construction of a basketball court and a bocce ball court and other upgrades is under way at Eliassen Park in between Upper Sunny Circle and Aurora Street. It looks like there will be a new Charter School located in the old Auto Max Building. Hopefully they will purchase or acquire a new US and Alaska State Flag to fly on those magnificent flag poles. With these and many other projects going on in our community, we will have to remain vigilant in becoming and staying aware of what is being developed and express our concerns that these projects be developed with the best interest of our community in mind. We can maintain and even improve our status as one of the 850 best cities to live in America if we continue to be involved. Involvement can take the form of becoming or remaining a member of your community council or the Chamber of Commerce and encouraging your friends and neighbors to do the same. You can also keep abreast of the issues by buying a subscription to the Alaska Star.

Speaking of community participation, congratulations and thanks to Brian Fay for taking over as Chair of the Chugiak/Eagle River Parks and Recreation Board. Via email, ERCC Board of Directors offered no objection to a letter as long as all municipal permitting and ordinances were adhered to.

There will be a title 21 workshop at the North Slope Restaurant August 24, 7 to 9 pm. This is an important issue concerning updating land use regulations and will affect development for decades to come. The current rewrite/update of the Eagle River Comprehensive Plan will be covered also.
