2. Tony Knowles Coastal Trail Erosion — need to include trail section erosion closer to Point Woronzof *(Move from #1 To #2)*
3. Turnagain St. Upgrade — Northern Lights Blvd. to 36th Ave. — need to **ADD** project *(Move from #2 To #3)*
4. Lakeshore Dr. Upgrade — Constellation Ave. to Wisconsin St.
5. Hillcrest Dr. Sidewalk — West High Campus to Forest Park Dr.
6. Esquire Dr. Sidewalk — Forest Park Dr. to Hillcrest Dr.
7. Turnagain Area Traffic Calming and Safety Improvements
8. Fish Creek Trail to Ocean — W. Northern Lights Blvd. to Tony Knowles Coastal Trail
9. Didlika Park — include projects identified by Girl Scout Brownie Troop 21004 (April 30, 2021 letter to MOA Parks and Recreation Department)
10. Lyn Ary Park
11. Spenard Beach Park Amenities — need to **ADD** project
12. Wisconsin St. Surface Rehab — Northern Lights Blvd to Spenard Rd.
13. Earthquake Park — need to **ADD** project
14. Wildwood Ln./Forest Park Dr. Trail
15. Milky Way Dr. Surface Rehab — Aero Ave. to Wisconsin St.
16. Turnagain Pkwy. Surface Rehab — Illiamna Ave. to Northern Lights Blvd.
17. West High and Romig Middle Schools Access and Circulation
18. Point Woronzof Overlook

DELETE:

- Campbell Creek Greenbelt
 - Project Area not within TCC Boundaries
- Campbell Creek Trail — Separated Grade Crossing @Lake Otis
 - Project Area not within TCC Boundaries
- Dog Park Site Selection and Design and Management Standards
 - No existing TCC Park Master Plan includes development of a dog park
 - TCC has not proposed a dog park in any Turnagain park without a Master Plan
- Northern Lights Blvd. Upgrade Phase IV — Postmark Dr. to Nathaniel Ct.
 - Please see specific language TCC has provided in previous years, including:
 - AMATS Policy Committee amendments (i.e., no sidewalk on south side; no center turn lane)
 - TCC long-time position: support ONLY maintenance/rehabilitation of existing pavement when needed
- Ship Creek Trail to the Tony Knowles Coastal Trail
 - Project Area not within TCC Boundaries
- West High and Romig Middle Schools Pedestrian Access Improvements
- West/Romig Schools Area Trail Resurfacing
 - The above two bullet item projects are **redundant**, but more importantly, **these projects have been completed**

NOT RANKED:

- Areawide Trail Safety Upgrades — No specific projects in TCC provided
- Community Garden Site Selection and Design and Management Standards
 - No existing TCC Park Master Plan includes development of a community garden
 - TCC has not proposed a community garden in any Turnagain park without a Master Plan
- Forest Health and Park Safety — No specific projects in TCC provided
- Margaret Eagan Sullivan Park — Not sure identified projects are located in TCC boundaries
- Systemwide Trail Wayfinding — No specific projects in TCC provided
