### Port of Alaska: Steve Ribuffo

- 1<sup>st</sup> cement ship of the year arriving in early May. Lights will go on for offloading. Lights now point down more and not up the hill. Requests feedback. Port now has control of intensity!
- Construction for north end of port modernization will begin late April, early May. 3 big barge mounted cranes will be in place to remove steel from failed expansion effort
- Will get result of lawsuit and if lower court award holds soon. Oral arguments for appeal were mid March.
- By end of June offices should be in new building.
- No scheduled open house. Mayor wanted to do a renaming ceremony on June 9 for Don Young Day but its ship day which is dangerous for general public. Now a small in-person ceremony and a televised version to be transmitted to a gathering at the Denaina Center.
- Port has a grant to purchase a battery storage power system. Will be placed near cell tower, above tsunami zone.


• Vehicle Emission Noise-Hans Thompson-

# Resolution 2024-XX: Commending APD's Vehicle Noise Enforcement & Advocating for Transparent Efforts

WHEREAS, the Anchorage Police Department (APD) has notably improved its capabilities by acquiring specialized vehicle noise enforcement equipment, aligning with community concerns;

WHEREAS, following the ombudsman's recommendations, the APD has actively pursued policy changes, advocating for higher fines to deter illegal vehicle muffler modifications, aiming for quieter neighborhoods;

WHEREAS, in summer 2023, the APD increased enforcement to address vehicle noise violations, enhancing community well-being;

**BE IT RESOLVED**, the Government Hill Community Council appreciates the APD for its swift actions in vehicle noise management, through equipment acquisition, policy development, and seasonal enforcement.

FURTHER BE IT RESOLVED, the Government Hill Community Council urges the APD to both continue and expand its efforts, balancing neighborhood-specific and municipality-wide enforcement to maintain community tranquility.

ADDITIONALLY, the Government Hill Community Council requests the APD to ensure transparency by publicly detailing its summer 2024 enforcement plans, including strategies and expected outcomes, to keep the community informed.

**MOREOVER**, following summer 2024, the Government Hill Community Council seeks a comprehensive report from the APD on enforcement outcomes, integrating both data and feedback to gauge effectiveness and make necessary adjustments.

**BE IT FINALLY RESOLVED**, this resolution underscores the Government Hill Community Council's appreciation for the APD's ongoing commitment and partnership in community safety and quality of life improvements.

Chugach BOD Election-AK Center-Alex Petkanas

Introduces Mark Wiggin and Sam Cason, incumbents who the Alaska Center supports based on their interests in renewables

Sam Cason, current Chair of CE Board of directors. "We are running against pro-coal challengers". Mark Wiggin, Chair of Operations Committee. Wants to build out Chugach Electric's renewable portfolio. (former Turnagain CC Chair). Notes that residents should have received an email at noon 4/17/24. Search for Chugach, "Chugach election contract" to find member ballot.

Wiggin and Cason: Clarifies that it is one vote per member – who ever has their name on the Chugach Electric bill.

### **OLD BUSINESS:**

• Traffic calming East side

Last month GHCC heard from East side residents on speeding on E Bluff Road. Chief Schrage made some phone calls on our behalf. We now have someone assigned to us to champion the issues on traffic. Randy Ribble with the muni Department of Traffic Engineering. Muni will set up electronic signs recording and transmitting speeds along E Hollywood and E Bluff, possibly also Cedar and Birch. It takes a while to collect enough data to support remediation prioritization.

President Sola: Snow plowing is not leaving enough room for fire trucks. Planning a physical walk/wheel through with Randy soon.

President Sola: It was a short notice to put a resolution together. GHCC submitted the version that was sent out with the agenda.
