## Residential Real Property Tax Exemption

Information on Owner-Occupied Residential Real Property Tax Exemption

On December 14, 2004, the Anchorage Assembly approved Assembly Ordinance No. 2004-167, providing for an owner-occupied residential real property tax exemption effective in tax year 2005. Under State law, a tax exemption must be ratified by municipal voters. The Municipality is accepting applications at this time to facilitate administration of the exemption for tax year 2005, in the event the ordinance is ratified by voters in the April 5, 2005 election.
